

#### **Executive Overview**

The sixth national NetHui was hosted at Aotea Centre in Auckland from 8-10 November 2017. The theme was "*Trust and Freedom on the Internet*," which was reflected throughout the event <u>programme</u>.

The event was overwhelmingly enjoyed by attendees, with the feedback survey showing 89% of respondents being either moderately or extremely satisfied with their NetHui 2017 experience, comparing to 75% in 2015 for the last national NetHui.

Overall, nearly 400 participants attended NetHui 2017 over the three days. Registration was \$55 per attendee for the Thursday and Friday. Wednesday's "Day 0" events were free to attend.

## **Participation**

Of the 400 participants who attended NetHui 2017 over the three days, most attended Days 1 and 2 (Thursday and Friday), and over 290 registered for the range of Day 0 events on Wednesday. Most who attended Day 0 also attended the main NetHui 2017 days.

Of participants, 49% were first time NetHui attendees. Demographics of NetHui 2017 attendees reflected in the survey were:

- 44% of respondents lived in Auckland and 35% travelled from Wellington.
- 29% of respondents were aged between 45 and 54, and 22% were aged between 35 and 44
- 76% of respondents identified as Pākehā, with the next biggest group being 14% identifying as other, and 10% identified as Māori.
- 51% of respondents identified as male, and 43% identified as female.

The cost of registration is kept low to facilitate participation, and a number of participants were given complimentary registration including facilitators, speakers, panelists, media, sponsors, students, photographers, council members and staff from InternetNZ, DNCL and NZRS. Together with InternetNZ's strategic partners, we ran promotional giveaway ticket competitions in order to promote NetHui 2017.

InternetNZ with APNIC enabled the attendance of seven New Zealand fellows by funding for travel, accommodation and/or childcare costs. One fellow from Vanuatu also attended NetHui, through sponsorship assistance from APTLD.

## Speakers, panelists and facilitators

There were three keynote speakers during the plenary sessions: Minister Clare Curran; Jillian C. York, the Director for International Freedom of Expression from Electronic Frontier Foundation (EFF), based in Berlin; and Pia Waugh, the Integrated Initiatives Team Lead from Lab+, at the Department of Internal Affairs (DIA).

There were three panel sessions:

- Freedom of Expression, otherness, safety and consequences

## Format and planning

## **Programme format**

The programme was developed through a call for suggestions and a "Get Involved" (expression of interest) process to the wider community through the media, community supporter organisations, social media and InternetNZ membership. These ideas were then refined through community meetings, and discussions with potential facilitators and contributors to connect related topics and design discussion sessions. Programme details were announced as confirmed, and the final programme with community-led content was launched on 10 October and can be viewed here.

Day 0 held all-day sessions organised by community working groups and organisations on Māori; copyright and open access; the second annual FLINT conference for young TUANZ members; and the OMGtech trailblazers workshop on the new Digital Technologies Curriculum.

A highlight of NetHui 2017 was the NZ Internet Research Forum (NZIRF), which linked NetHui with various New Zealand Internet researchers on Day 0.

NetHui Days 1 and 2 explored the future of Internet, digital inclusion/divide and literacy, trust, social and cultural influence, freedom of expressions as well as privacy and the harmful digital communications act and much more. These topics were discussed through panels, sessions and keynotes.

For session timekeeping this year, we continued to use Tūī calls that Radio New Zealand kindly loaned NetHui to bring sessions to a wrap.

A Barcamp session on Day 2 continued discussions from the previous day on 'Nudes: Where's the real harm?', exploring privacy and safety online, and strategies for better equipping those who share private photos to know their rights and what measures to take if they are violated. Informal Barcamp sessions also continued to discuss digital divides and rural access.

There were a number of related events and meetups around NetHui - Digital literacy special interest group, NetSquared, Digital Natives Academy and Internet Startups, Entrepreneurs, and Social Entrepreneurs.

## Kaupapa & Tūī safety team

Based on feedback from previous years, NetHui 2017 continued using a transparent and active approach to the kaupapa for all attendees and online commentary. The approach to the kaupapa was designed to ensure everyone's opinions and ideas were equally valued and that everyone involved in (or commenting online about) NetHui was respected.

The four pillars of this approach were:

- Respect people
- Enable participation
- Stay on topic
- Keep it safe.

A more extensive <u>Code of Conduct</u> was available online, and participants and online commenters were directed to read the code if any issues arose. Attendees were also briefed on the Code of Conduct and the Tuī Team by our MC Michele A'Court, as part of the NetHui 2017 opening.

The Tuī Team was NetHui 2017's safety team. They were there to support and enforce the Code of Conduct, providing any assistance in making sure that everyone was feeling safe and secure while at NetHui. Tuī team wore yellow lanyards and a soft toy Tuī. Alternatively, there was an online form set up for those wanting to stay anonymous. All sessions were attended by at least one Tuī Team member.

Overall, we received three notifications of different incidents. No in-person Code of Conduct warnings were issued.

## Accessibility

To promote accessibility, all panels and keynotes were live captioned by Chris Penman, I-Film, whom we have built a good relationship with through InternetNZ Speaker Series and NetHui Roadshow 2016. These sessions can be viewed online at:

Services to enable better access for attendees who have sight or hearing impairments were ready to be implemented, however no attendees indicated that they would like these services to be provided.

## **Engagement**

## Participant Feedback Survey results

All attendees and facilitators of NetHui were sent a <u>survey</u> to provide feedback on their NetHui experience. We received 95 responses, the key points of which included:

#### **Attendance**

- 49% of respondents had previously attended a NetHui (55% at 2015).
- 36% of attendees who responded heard about NetHui through word of mouth.
- Respondents' reasons for attending NetHui 2017 included attendees working in the sector;
   wanting to talk, to learn, to listen; and to connect with others in the Internet community.
- Most respondents were from the technology sector, followed by business, civil society and academic sectors. A major trend in the 'other' sector was government.
- 44% of respondents lived in Auckland and 35% travelled from Wellington.
- 29% of respondents were aged between 45 and 54, and 22% were aged between 35 and 44.
- 76% of respondents identified as Pākehā, with the next biggest group being 14% identifying as other, and 10% identified as Māori.
- 51% of respondents identified as male, and 43% identified as female.

#### **Experience and Expectations**

- 89% of respondents were either moderately or extremely satisfied with their NetHui 2017 experience (75% at 2015).
- 82% of respondents said they were able to voice their thought and opinions and also felt safe (88% 2015) at NetHui 2017, with feeling welcome at 76% (90% 2015), included at 65% (80% 2015).
- 81% of respondents said NetHui was either mostly what they expected or exactly what they expected (81% at 2015).
- 78% of respondents said they received all or most of the information they needed on NetHui beforehand (78% at 2015).

#### **Comments**

- What value respondents personally gained from NetHui 2017 included networking; new ideas; and discussions with likeminded people, diversity and different perspectives. Clare Curran and Pia Waugh's keynotes were mentioned as some of the highlights.
- What respondents disliked about NetHui 2017 included some sessions were too loosely facilitated, lack of clear focus in some sessions and a lack of 'where to from here' on some issues.
- Suggestions for improvement included more information about sessions before the event which could also be used for further promoting; more Māori participation and topics.
- Other topics respondents would like to see covered at NetHui included digital divide; Al; new tech; education; safety; and cybersecurity.
- Other feedback included praises of the food, venue, keynotes and the code of conduct.

### **Online**

All Day 1 and 2 sessions at NetHui, except for Barcamps, were streamed live online by I-Film. Every session had a collaborative note taking page. The livestream videos were available on the NetHui website and engagement between remote participants and those at the event was enabled by an embedded Mibbit (IRC) widget and through Twitter. All panels and keynotes were live captioned on the video stream. Streaming videos and collaborative note taking were accessible through the <u>live programme</u>.

Sessions were viewed by a total of 3,020 viewers who spent close to 40,000 minutes in total watching all four streams over two days. The average viewing time was just over 18 minutes. New Zealand viewers made up 78% of our remote audience, with 11% from Australia, 6% from the U.S. and 5% from other countries.


Throughout the three days, <u>#NetHui</u> was consistently trending in the top three New Zealand Twitter hashtags.





How did you hear about NetHui 2017? Please check all that apply.




Have you attended a NetHui event before? Please check all that apply.




Which of these communities or sectors do you most strongly identify with? Please check all that apply.






What gender do you most strongly identify with? (you can tick multiple options)




# Where do you live?






# What is your ethnicity? Please check all that apply.Definition of ethnicity (Statistics New Zealand)


